



RULES

Only 53,000 tickets will be sold

- \$100 each, 3-pack for \$250, 5-pack for \$375, Super Pack for \$500 (includes 6 – Home Lottery tickets, 15 – 50/50 Add-On® tickets and 3 – 100 Days of Winning® Cash Calendar™ Add-On tickets), Max Pack for \$850 (includes 10 – Home Lottery tickets, 25 – 50/50 Add-On® tickets and 6 – 100 Days of Winning® Cash Calendar™ Add-On tickets).
- All tickets in a 3-pack, 5-pack, Super Pack or Max Pack and all Add-Ons in a 3-pack, 6-pack, 15-pack or 25-pack must contain the same name and contact information.
- Tickets must be purchased and mailed within Saskatchewan.
- Only tickets that have been verified as paid for are eligible for the respective draws.
- Must be 18 years of age or older. Tickets cannot be purchased in the name of a minor.

DRAW DATES

VIP Ticket Sales Deadline: Midnight, January 31, 2020.

VIP Draw Date: February 13, 2020.

Bonus Ticket Sales Deadline: Midnight, February 21, 2020.

Bonus Draw Date: March 5, 2020.

Early Bird Ticket Sales Deadline: Midnight, March 20, 2020.

Early Bird Draw Date: April 1, 2020*.

Early Bird Winner Announcement: April 2, 2020.

Final Ticket Sales Deadline: Midnight, April 3, 2020**.

Final Draw Date: April 15, 2020.

Grand Prize Winner Announcement: April 16, 2020.

Only tickets purchased before midnight, January 31, 2020, will be eligible to win the VIP Prize. VIP draw will commence at 10 a.m. February 13, 2020.

Only tickets purchased before midnight, February 21, 2020, will be eligible to win the Bonus Prize. Bonus draw will commence at 10 a.m. March 5, 2020.

*Only tickets purchased before the Early Bird ticket sales deadline of midnight, March 20, 2020, are eligible to win the Early Bird Prize. If all tickets are sold by the Early Bird ticket sales deadline, all draws including the 50/50 Add-On and the 100 Days of Winning Cash Calendar Add-On will commence at 8:30 a.m. April 1, 2020. The top prize winners will be announced on April 2, 2020.

**If tickets remain after the Early Bird ticket sales deadline, then only the Early Bird draw will commence between 8:30am and 2pm on April 1, 2020. Final ticket sales deadline is midnight, April 3, 2020. The remaining prize draws, including the 50/50 Add-On and the 100 Days of Winning Cash Calendar Add-On, will commence at 8:30 a.m. April 15, 2020. The top prize winners will be announced on April 16, 2020.

DRAW ORDER AND PROCEDURE

The first draw is for the VIP Prize. The second draw is for the Bonus Prize. The next draw is for the Early Bird Prize; then draws are made in the order of the ascending retail value, beginning with the prizes of least retail value.

After each draw, including the VIP, Bonus, and Early Bird draws, the winning ticket number is recorded and the ticket number is eligible for subsequent draws. Each ticket purchased before the VIP ticket sales deadline is eligible for 1,005 prizes. Each ticket purchased after the VIP ticket sales deadline but before the Bonus ticket sales deadline is eligible for 1,002 draws. Each ticket purchased after the Bonus ticket sales deadline but before the Early Bird ticket sales deadline is eligible for 1,001 draws. Tickets purchased after the Early Bird ticket sales deadline will be eligible for the remaining 1,000 draws. All draws will be held at the offices of MNP LLP. The top valued prize draw announcements may be televised at the Grand Prize Showhome.

Prize draws follow a strict set of procedures, with draw control oversight by MNP LLP and under licensing approval by the licensing body, Saskatchewan Liquor and Gaming Authority (SLGA).

Each prize draw will select one (1) winner at random. All draws are open to ticket holders. The draws will be completed using Random Number Generator (RNG). A draw will only be deemed valid and complete upon final confirmation and recording by MNP LLP.

†50/50 Add-On and 100 Days of Winning Cash Calendar Add-On tickets must be ordered in conjunction with your Hospital Home Lottery ticket(s). 50/50 Add-On and 100 Days of Winning Cash Calendar Add-On orders will not be accepted after your original Hospital Home Lottery ticket order date.

A maximum of 244,200 50/50 Add-Ons are available for sale. There are 100 prizes in the 100 Days of Winning Cash Calendar Add-On with a total prize value of \$100,000. A maximum of 48,000 100 Days of Winning Cash Calendar Add-Ons are available for sale. 100 Days of Winning Cash Calendar Add-On winner's information will be posted daily on the lottery website beginning May 15, 2020, according to the sequential manner in which they were drawn.

In the event that all tickets are sold by the Early Bird ticket sales deadline of midnight, March 20, 2020, the Add-On draws will take place on April 1, 2020. If tickets remain after the Early Bird ticket sales deadline, the Add-On draws will take place April 15, 2020.

All winners of prizes will be notified in writing by MNP LLP as to what they have won and how to claim prizes. All prizes must be accepted as awarded with no cash equivalents available unless otherwise described in the brochure.

All prizes should be claimed within one (1) year of the applicable draw date. In the event that winners have not claimed their prizes within that period, and after reasonable attempts have been made to contact that winner (i.e. telephone, mail), then the prize will be submitted to a charity approved by the SLGA.
